Ultimate Fan Experience Terms and Conditions of Entry

- 1. The promotion is called **Ultimate Fan Experience** (**Promotion**). Information on how to enter and the prizes to be won form part of these Terms and Conditions.
- 2. By participating in this Promotion, you agree to be bound by these Terms and Conditions.
- 3. The Promotion is conducted by Cricket Tasmania, the trading name of Tasmanian Cricket Association ABN 34 009 476 993, (Cricket Tasmania or we or us or our). The Promotion is conducted in Tasmania.
- 4. The Promotion commences at 00:01 Australian Eastern Daylight Time (AEDT) on 3 July 2023 and closes at 23:59 Australian Eastern Daylight Time (AEDT) on 4 January 2024 (**Promotional Period**).
- 5. To enter the Promotion (Entrant), you must:
 - a. hold a membership in your name under any membership package from the 2023-2024 Hobart Hurricanes membership (including renewal) (**Membership**); and
 - b. be a resident in Tasmania that is, your ordinary place of residence (and the address noted on your Membership application form) is in Tasmania.

For the avoidance of doubt, Entrants include Tasmanian residents under the age of 18 holding Membership.

- 14. Cricket Tasmania reserves the right to verify the validity of entries (including an Entrant's identity and place of residence). Cricket Tasmania reserves the right, subject to applicable legislation, to disqualify any purported Entrant who Cricket Tasmania determines has tampered with the entry process or has submitted an entry that is not in accordance with these Terms and Conditions (Ineligible Entrant).
